DISCIPLINE RULES

Students of the Institute are required to follow the points mentioned below for maintenance of discipline in the campus:

1. The students are required to attend a minimum of 85 % of the classes to be sent-up for the examination. In extraordinary and compelling circumstances where the attendance is less than 85% on account of (a) prolonged sickness (b) marriage of self (c) death of one of the parents or guardian, the students shall be allowed to take the examination with attendance less than 85% but more than 75% upon submission of an undertaking, In such a case the students are required to intimate immediately the cause to the Director in writing for permission.
2. Attendance in all the programmes/courses as notified by the authority shall be compulsory.
3. Compliance of instructions/orders of the authority/authorities in respect of discipline/academics/ examination/ attendance/ placement/ summer training/ organised special programmes etc. shall have to be strictly followed without fail.
4. Use of unfair means in the examinations is strictly prohibited & punishable.
5. Speaking loudly, gossiping and loitering in the Institute campus are acts of indiscipline. Chewing of Tobacco & SMOKING is strictly prohibited in the campus.
6. Indecent behaviour with faculty members, staff, students and others will be treated as misconduct and may result in strict disciplinary action which includes expulsion from the Institute.
7. Late coming in the class shall be considered as absence from the class. Cases of proxy attendance will be treated as an act of gross misconduct. Students indulging in proxy attendance shall be penalized with marking absent from the particular class and may also invite disciplinary action against them.
8. Any act which causes damage to the asset/s of the Institute will be considered to be an act of Indiscipline, misconduct and shall invite strict punitive action including individual or collective fine and expulsion.
9. The Institute has state of art library with the best collection of books & journals. Students are advised to take maximum advantage of the library. Every student should observe strict discipline and maintain absolute silence in the library. Students are expected to deposit their bag etc. at the deposit counter before entering the library. Timely return of books and payment of dues to the library are compulsory. Fine/s shall be charged on overdue books as per the library rules.
10. Students are required to attend classes or any function in the Institute with the Identity Card to be provided by the Institute.
11. Limited parking facility for student's two-wheeler is available at their own risk. No car is allowed inside the campus for the students modified bike shall not be allowed inside the campus. Housing inside the campus is strictly prohibited.
12. Intoxicating substance, smoking and taking of drug are illegal & is strictly prohibited. Any student found to be taking such a measure shall be punished for this gross misconduct.
13. Chewing and spitting of "Pan" in the classroom/library/computer centers or anywhere else in the premises is strictly prohibited. Student/s found spitting Pan/tobacco shall be heavily fined and strict disciplinary action shall be taken as well. Apart from the punitive action individually, if spitting of "Pan" is found inside the classroom/passageway or on the wall thereof or elsewhere, collective fines too shall be imposed on the class as a whole besides the individual fines as stated above.
14. Use of mobile phone is strictly prohibited in Academic Building, Technical Building Administrative Building including Classrooms, Library, Computer Lab, Auditorium and in passages/corridors. However, students are allowed to use the mobile phone in cafeteria, canteen and outside in the premises with limited restriction. Students found violating the

provision may lead to heavy fine and seizure of their mobile phone. Similarly, the students are not supposed to use mobile phones in the guest lectures and other special occasions as well. It shall be individual responsibility of the students for safe keeping of their Mobile phones and other valuables. However, students are advised not to bring valuables to the Institute. Students depositing their valuables in the Library/Enquiry Counters shall be at their risk and are advised to take particular care of their valuables, including mobile phones. The Institute does not take any responsibility for the missing things.

15. Grievances are to be brought to the notice of the authorities through proper channel only. The decision of the Director shall be final in such matter.

16. Students both Boys and Girls shall strictly follow the prescribed dress code.

17. Ragging in any form is strictly prohibited. Under the instructions of the Hon'ble Supreme Court of India and through the AICTE special instructions have been issued against Ragging. If any student/students are found involved in act of ragging following punishment/s shall be imposed:

i. Cancellation of Admission.

ii. Suspension from attending classes.

iii. Withholding/withdrawing scholarship/fellowship and other benefits.

iv. Debarring from appearing in any test/examination or other evaluation process.

v. Withholding results.

vi. Debarring from representing the institution in any national or international meet, tournament, youth festival etc.

vii. Suspension/expulsion from the hostel, if any.

viii. Rustication from the institution for period varying from 1 to 6 semesters.

Expulsion from the Institution and consequent debarring from admission to any other institutions.

ix. Fine up to Rs. 25,000/-

x. In case of ragging involving violence, the matter will be referred to a Court of Law through a proper case and in such cases rigorous imprisonment will also be imposed depending upon the existing laws.

In case of Ragging in any form, the students are advised to report the matter immediately to the Director or to the Registrar and to the members of the Disciplinary/Ragging Committee constituted for this purpose. Further as per the directive of AICTE, Anti Ragging Squads have been formed for Academic, Technical and Administrative Building to safeguard students from any such incident.

18. Students shall maintain strict discipline and restraint over social media post, clipping, reels etc.. No student is allowed to post the media clipping, video clipping, posts wearing Institute uniform on any of the social media platform like facebook, instagram, snapchat etc. without approval of the competent authority. It is strictly advised to students not to post objectionable, inappropriate intimidating, violent, offensive, vulgar, hate spreading content/post on social media against any individual / group of individuals/ community/ faith/ colleagues/ senior/ staff etc. Any student violating this provision, shall be punished strictly including expulsion and lodging of report under IT Act.

19. The students are supposed to follow the disciplinary rules strictly and conduct themselves in such a manner with dignity and self restrain that the prestige of the Institution and their own prestige is maintained.
