Caste, Income (only for EBC & BC candidates) and Domicile Certificates (for reserved category candidates) in original issued by competent authority ; Original certificate of Disabilities in terms of the provisions of the persons with Disabilities (Equal Opportunities, Protection of Rights & Full Participation) Act., 1995, issued by the Medical Board (if Applicable);
7. Two Separate Drafts/Online payments, one for Rs. 1,02,000.00/- (Rs. One Lac Two Thousand only) for General / All Backward Classes Candidates and Rs. 56,000/- (Rs.
