2. College Leaving Certificate (CLC, if applicable);
3. Migration Certificate;
4. Mark-Sheets of Class X, +2/Intermediate & Graduation (as applicable);
5. Relevant Certificate for reserved category candidates under EWS.

Caste, Income (only for EBC & BC candidates) and Domicile Certificates (for reserved category candidates) in original issued by competent authority ; Original certificate of Disabilities in terms of the provisions of the persons with Disabilities (Equal Opportunities, Protection of Rights & Full Participation) Act., 1995, issued by the Medical Board (if Applicable);
7. Two Separate Drafts/Online payments, one for Rs. 1,02,000.00/- (Rs. One Lac Two Thousand only) for General / All Backward Classes Candidates and Rs. 56,000/- (Rs. Fifty Six Thousand only) for SC / ST candidates and Second Draft/Online Payment for Rs. 10000 (Rs. Ten Thousand Only) as Acceptance Fee in favour of the Director, L. N. Mishra Institute of Economic Development and Social Change payable at Patna has to be deposited at the time of admission, as 1<sup>st</sup> installment of Course Fee and Development Charge.
