## ACADEMIC PROGRAMME

The Institute offers the following Post Graduate and Graduate Programmes:

1. Two-Year Full-Time Master of Business Administration (MBA)
2. Two-Year Full-Time Master of Computer Applications (MCA)
3. Two-Year Full-Time MBA (Human Resource Development - HRD)
4. Two-Year Full-Time MBA (International Business - IB)
5. Two-Year Full-Time MBA (Logistics and Supply Chain Management - LSCM)
6. Two-Year Full-Time MBA (Finance)
7. Three-Year Full-Time Bachelor of Business Administration (BBA)
8. Three-Year Full-Time Bachelor of Computer Applications (BCA)
9. **Five-Year Full-Time MBA (Integrated):** This program is an intensive, five-year management course divided into two distinct stages. It is designed to nurture leadership and managerial skills from the very beginning of a student's higher education. A BBA degree is awarded after successful completion of the first 3 years. Upon completing the full 5-year duration, the student is eligible for the MBA (Integrated) degree.
10. **Five-Year Full-Time MCA (Integrated):** Designed for technology enthusiasts, this program provides a comprehensive path from basic computer applications to advanced software engineering and data science. A BCA degree is awarded after the first 3 years. The final MCA (Integrated) degree is awarded after successful completion of the 5-year program.



## ADMISSION PROCEDURE

The admission process is centrally managed for all courses and is based on merit, entrance test scores, and performance in the personal assessment rounds.

- (i) For Applicants of post graduate Management Programme MAT/CMAT/CAT score is required followed by GD & PI test. Post graduate computer course and under graduate courses (Managements & Computer) the selection is done after test.
- (ii) Aspirants must apply online for registration on the Institute's website.
- (iii) Prospectus and the application form may be downloaded from the Institute website [www.lnmipat.ac.in](http://www.lnmipat.ac.in).
- (iv) Registration fee for on-line application form is Rs. 1500/- only (for SC/ST candidates Rs. 750/- only).
- (v) Admissions fee is to be deposited through challan or online in Indian Bank, Patna A/c No. 50386731675 and HDFC A/c No. 50100231703610.
- (vi) Online application without fees shall be rejected.
- (vii) RESERVATION is applicable as per Govt. of Bihar Rules.
- (viii) Appearing candidates can also apply on the condition that they have to produce passing certificate at the time of admission.
- (ix) NRI / PIO seats available in PG Courses as per the AICTE norms.
- (x) Schedule for GD and PI shall be communicated by the Institute.
- (xi) Entrance Tests shall be held in English Medium.
- (xii) **Foreign Nationals, NRIs etc :** A few seats are reserved for such candidates on supernumerary basis in MBA, MBA (HRD) & MCA. They are admitted strictly as per the guidelines/rules prescribed by the AICTE, New Delhi. However, such students will be required to appear at Group Discussion (G.D.) and Personal Interview (P.I.), Conducted by the Institute as part of the admission test. (NRI as defined under the Income Tax Act)
