2. College Leaving Certificate (CLC, if applicable);
3. Migration Certificate and CAT/CMAT/MAT Score Card ;
4. Mark-Sheets of Class X, +2/Intermediate & Graduation (as applicable);
5. Relevant Certificate for reserved category candidates under EWS.
6. Caste, Income (only for EBC & BC candidates) and Domicile Certificates (for reserved category candidates) in original issued by competent authority ; Original certificate of Disabilities in terms of the provisions of the persons with Disabilities (Equal Opportunities, Protection of Rights & Full Participation) Act., 1995, issued by the Medical Board (if Applicable);

Two Separate Drafts/Online Payments- One for Rs. 1,02,000/- (Rs. 97000/- as Tution fee and Rs. 5000 as University Registration and Miscellaneous charges) for General / All Backward Classes Candidates and Rs. 56000/- (Rs. 51000/- as Tution fee and Rs. 5000/- University Registration and Miscellaneous charges) for SC / ST candidates and Second Draft / Online Payment of Rs. 10000 (Rs. Ten Thousand Only) as Acceptance Fee for all categories candidates in favour of the Director, L. N. 11. If any candidate desires extension of the date for admission, the candidate will have to transfer Rs. 10,000.00 (ten thousand) only as Counseling Fee through Online using above mentioned bank details.

The Institute has right to cancel your admission as and when required.
