5. Relevant Certificate for reserved category candidates under EWS.

Caste, Income (only for EBC & BC candidates) and Domicile Certificates (for reserved category candidates) in original issued by competent authority ; Original certificate of Disabilities in terms of the provisions of the persons with Disabilities (Equal Opportunities, Protection of Rights & Full Participation) Act., 1995, issued by the Medical Board (if Applicable);
7. Two Separate Drafts/Online payments, one for Rs. 65,000.00/- (Rs. Sixty Five Thousand only) for General / All Backward Classes Candidates and Rs. 35,000/- (Rs. Thirty Five Thousand only) for SC / ST candidates and Second Draft/Online Payment for Rs. 10000 (Rs. Ten Thousand Only) as Acceptance Fee in favour of the **Director, L. N. Mishra Institute of Economic Development and Social Change payable at Patna** has to be deposited at the time of admission, as 1st installment of Course Fee and Development Charge.
