2. College Leaving Certificate (CLC, if applicable);
3. Migration Certificate;
4. Mark-Sheets of Class X, +2/Intermediate & Graduation (as applicable);
5. Relevant Certificate for reserved category candidates under EWS.

Caste, Income (only for EBC & BC candidates) and Domicile Certificates (for reserved category candidates) in original issued by competent authority ; Original certificate of Disabilities in terms of the provisions of the persons with Disabilities (Equal Opportunities, Protection of Rights & Full Participation) Act., 1995, issued by the Medical Board (if Applicable);

Two Separate Drafts/Online Payments- One for Rs. 1,02,000/- (Rs. 97000/- as Tution fee and Rs. 5000 as University Registration and Miscellaneous charges) for General / All Backward Classes Candidates and Rs. 56000/- (Rs. 51000/- as Tution fee and Rs. 5000/- University Registration and Miscellaneous charges) for SC / ST candidates and Second Draft / Online Payment of Rs. 10000 (Rs. Ten Thousand Only) as Acceptance Fee for all categories candidates in favour of the **Director, L. N.
