However, reserved category candidates under EWS will have to furnish relevant certificate issued by the competent authority.

Further, all the candidates who have been provisionally selected for admission subject to fulfillment of eligibility criteria, will have to furnish the following documents in original as well as one set of self attested photocopy of the original documents at the time of admission for verification & submission:

1. Four recent photographs two passport size and another two stamp size;
2. College Leaving Certificate (CLC, if applicable);
3. Migration Certificate;
4. Mark-Sheets of Class X, +2/Intermediate & Graduation (as applicable);
5. Relevant Certificate for reserved category candidates under EWS.
6. Caste, Income (only for EBC & BC candidates) and Domicile Certificates (for reserved category candidates) in original issued by competent authority ; Original certificate of Disabilities in terms of the provisions of the persons with Disabilities (Equal Opportunities, Protection of Rights & Full Participation) Act., 1995, issued by the Medical Board (if Applicable);

Two Separate Drafts/Online Payments- One for Rs. 1,02,000/- (Rs. 97000/- as Tution fee and Rs. 5000 as University Registration and Miscellaneous charges) for General / All Backward Classes Candidates and Rs. 56000/- (Rs. 51000/- as Tution fee and Rs. 5000/- University Registration and Miscellaneous charges) for SC / ST candidates and Second Draft / Online Payment of Rs. 10000 (Rs. Ten Thousand Only) as Acceptance Fee for all categories candidates in favour of the Director,

L. N. Mishra Institute of Economic Development and Social Change payable at Patna has to be deposited at the time of admission as 1st installment.

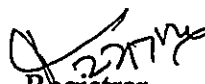
